RELEASE AND WAIVER OF LIABILITY AND PARENTAL CONSENT AGREEMENT

In consideration for participating as a camper at Camp Wilderness, both Minor and Guardian hereby freely and voluntarily, without duress, execute this Release under the following terms:

1. My signature below, attest that I am the parent or legal guardian of the Minor named in this Waiver and Release, and that I have the authority to execute this Waiver and Release on behalf of the Minor.
2. The Guardian and Minor each release and forever discharge and hold harmless Camp Wilderness and their respective agents, staff, volunteers and affiliates, and assigns from any and all liability, claims of whatever kind or nature, which arise or may hereafter arise from the Minor's participation at Camp Wilderness. The Guardian and Minor each understand and acknowledge that this Release discharges Camp Wilderness from any liability or claim that Guardian and Minor may have against Camp Wilderness with respect of bodily injury, personal injury, illness, death, or property damage that may result from activities while attending Camp Wilderness.
3. The guardian and minor each understand that we expressly waive any such claim for compensation or liability on the part of Camp Wilderness.
4. The Guardian and Minor each hereby release and forever discharge Camp Wilderness from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during the Minor's time at Camp Wilderness.
5. The Guardian and Minor each understand that the Minor's time while at Camp Wilderness may include activities that may be hazardous to the Minor including, but not limited to, construction activities and horseback riding, and interaction with other animals. We understand the Minor's activities at Camp Wilderness may, involve activities which can pose risk of harm or injury to the Minor. As the Minor's Guardian I, and the minor hereby expressly assume the risk of injury or harm in these activities and release Camp Wilderness from all liability for injury, illness, death or property damage resulting from the Minor's activities or the Minor's time at Camp wilderness. Guardian and Minor agree that if anyone makes a claim against Camp Wilderness on behalf of Guardian or Minor, that Guardian and Minor agree to indemnify, save and hold harmless Camp Wilderness from any claim, including without limitation, loss, liability, damage or cost which may occur as a result of any such claim.
6. As the guardian of said minor I, and the Minor each grant and convey unto Camp Wilderness all right, title, and interest in all images and video or audio recordings made by Camp Wilderness during the minor's stay at Camp Wilderness.
7. As the guardian of said minor I, and the Minor each understand that the Minor's behavior at Camp Wilderness must comply with all rules and regulations set forth by those in charge will attending the camp.
